I acknowledge that customers will be held financially responsible for any damage, alterations, or disturbances resulting from their use of the City owned property and/or equipment.

I agree to comply with all City of Dallas regulations governing the operation and use of the bulk water facility.

I understand that the customer must use approved equipment when purchasing bulk water. The 1" or 2" hose be hard-connected to the tank and water is not allowed to flow through an unsecured hose. I further agree to pass this information on to all members/users on my account.

I understand tanks must be vented while filling.

I agree returned checks will incur a fee, and account may be closed.

I agree to notify the City of any change in authorized members on the account and that the City will not be responsible for unauthorized use of my bulk water account.

I understand that bulk water accounts can be paid online at **www.portapay.com** using a major credit card. Credit applied to accounts is usually available immediately.

I understand water is delivered using waterline pressures and caution must be used to ensure safety.
